Purpose of the plan

This plan examines potential risks and issues that could cause disruption to the exams process at Beech Lodge School. By outlining actions/procedures to be invoked in case of disruption it is intended to mitigate the impact these disruptions have on our exam process.

Alongside internal processes, this plan is informed by the Ofqual (and Northern Ireland Council for the Curriculum, Examinations and Assessment) **Exam system contingency plan: England, Wales and Northern Ireland** which provides guidance in the publication *What schools and colleges and other centres should do if exams or other assessments are seriously disrupted* and the **JCQ Joint Contingency Plan** for the Examination System in England, Wales and Northern Ireland and the JCQ document **Preparing for disruption to examinations** (Effective from 1 September 2023).

This plan also confirms Beech Lodge School's compliance with JCQ's **General Regulations for Approved Centres** (section 5.3) that the centre has in place:

- a written examination contingency plan which covers all aspects of examination administration. This will allow members of the senior leadership team to act immediately in the event of an emergency or where the head of centre, examinations officer or SENCo is absent at a critical stage of the examination cycle. The examination contingency plan should reinforce procedures in the event of the centre being unavailable for examinations, or on results day, owing to an unforeseen emergency. The potential impact of a cyber-attack should also be considered.

National Centre Number Register and other information requirements

The head of centre will also ensure that Beech Lodge School has a contingency to enable the prompt handling of urgent issues only, responds to the awarding bodies' request for information regarding the contact details of a senior member of staff (which might include a personal mobile number and/or email address). This will ensure that any urgent matters which might adversely affect candidates which arise outside of term time, and which potentially put qualification awards at risk, can be addressed by awarding bodies with the support of that member of staff. Heads of centre should ensure that this member of staff has the necessary authority to mobilise resources to provide this support, which might include resolving issues within the centre itself.

Possible causes of disruption to the exam process

1. Exam officer extended absence at a critical stage of the exam cycle

Criteria for implementation of the plan

Key tasks required in the management and administration of the exam cycle not undertaken including:

Planning

- *annual data collection exercise not undertaken to collate information on qualifications and awarding body specifications being delivered*
- *annual exams plan not produced identifying essential key tasks, key dates and deadlines*
- *sufficient invigilators not recruited*

Entries

- *awarding bodies not being informed of early/estimated entries which prompts release of early information required by teaching staff*
- *candidates not being entered with awarding bodies for external exams/assessment*
- *awarding body entry deadlines missed or late or other penalty fees being incurred*

Pre-exams

- *invigilators not trained or updated on changes to instructions for conducting exams*
- *exam timetabling, rooming allocation; and invigilation schedules not prepared*
- *candidates not briefed on exam timetables and awarding body information for candidates*
- *confidential exam/assessment materials and candidates' work not stored under required secure conditions*

- *internal assessment marks and samples of candidates' work not submitted to awarding bodies/external moderators*

Exam time

- *exams/assessments not taken under the conditions prescribed by awarding bodies*
- *required reports/requests not submitted to awarding bodies during exam/assessment periods, for example very late arrival, suspected malpractice, special consideration*
- *candidates' scripts not dispatched as required for marking to awarding bodies*

Results and post-results

- *access to examination results affecting the distribution of results to candidates*
- *the facilitation of the post-results services*

Centre actions to mitigate the impact of the disruption

- *Exam Officer to keep Head of Centre updated about all aspects of the exam cycle*
- *Head of Centre to verify and check the entries with the School Administrator*
- *Additional admin support to be put in place if needed, from the front office*
- *Assistant Head and School Administrator to be constantly updated and trained on examination procedures and changes in line with awarding body and JCQ regulations*
- *Head of Centre to oversee training for invigilators in Exam Officers absence*

2. ALS lead/SENCo extended absence at a critical stage of the exam cycle

Criteria for implementation of the plan

Key tasks required in the management and administration of the access arrangements process within the exam cycle not undertaken including:

Planning

- *candidates not tested/assessed to identify potential access arrangement requirements*
- *centre fails to recognise its duties towards disabled candidates as defined under the terms of the Equality Act 2010*
- *evidence of need and evidence to support normal way of working not collated*

Pre-exams

- *approval for access arrangements not applied for to the awarding body*
- *centre-delegated arrangements not put in place*
- *modified paper requirements not identified in a timely manner to enable ordering to meet external deadline*
- *staff (facilitators) providing support to access arrangement candidates not allocated and trained*

Exam time

- *access arrangement candidate support not arranged for exam rooms*

Centre actions to mitigate the impact of the disruption

- *Assistant Head/Head of Centre to oversee the SENCo role*
- *Examination Officer to have liaised with the Head of Centre on examination arrangements, applications for additional needs and allocation of support staff*

3. Teaching staff extended absence at a critical stage of the exam cycle

Criteria for implementation of the plan

Key tasks not undertaken including:

Early/estimated entry information not provided to the exams officer on time; resulting in pre-release information not being received

Final entry information not provided to the exams officer on time; resulting in candidates not being entered for exams/assessments or being entered late/late or other penalty fees being charged by awarding bodies

Non-examination assessment tasks not set/issued/taken by candidates as scheduled

Candidates not being informed of centre assessed marks before marks are submitted to the awarding body and therefore not being able to consider appealing internal assessment decisions and requesting a review of the centre's marking

Internal assessment marks and candidates' work not provided to meet awarding body submission deadlines

Centre actions to mitigate the impact of the disruption

- *Escalation process – should the Head of Centre be absent, the Headteacher will take over the role as Head of Centre*
- *Assistant Head to complete necessary paperwork, following a data review*
- *Additional specialist support to be sought from partner school and local school network if needed*

4. Invigilators - lack of appropriately trained invigilators or invigilator absence

Criteria for implementation of the plan

Failure to recruit and train sufficient invigilators to conduct exams

Invigilator shortage on peak exam days

Invigilator absence on the day of an exam

Centre actions to mitigate the impact of the disruption

- *Admin staff and LSAs have been dual trained to step in, in case of an emergency or absence*

5. Exam rooms - lack of appropriate rooms or main venues unavailable at short notice

Criteria for implementation of the plan

Exams officer unable to identify sufficient/appropriate rooms during exams timetable planning

Insufficient rooms available on peak exam days

Main exam venues unavailable due to an unexpected incident at exam time

Centre actions to mitigate the impact of the disruption

- *Head of Centre to close the school to certain year groups if needed, due to unplanned incidents to free up space for the examinations*
- *Head of Centre to prioritise rooming for examinations and have arranged for classes to be moved to other areas*
- *Relocate to alternative venue if necessary – Berkshire College of Agriculture*

6. Cyber-attack

Criteria for implementation of the plan

Where a cyber-attack may compromise any aspect of delivery

Centre actions to mitigate the impact of the disruption

- *Up to date Anti-Virus software installed on all hardware throughout the school.*
- *Hard drive scans carried out regularly by IT Manager.*
- *Exams Officer/IT Manager to seek ICT specialist help from external provider (TSI) to resolve the issue as quickly as possible.*
- *Exams Officer/IT Manager to contact the NCSC.*
- *Exams Officer to contact DfE and the relevant Awarding Bodies to seek further guidance.*
- *Senior Leaders will monitor the situation and take any action required as directed by the Awarding Bodies.*

7. Failure of IT systems

Criteria for implementation of the plan

MIS system failure at final entry deadline

MIS system failure during exams preparation

Power outage immediately prior to or during an on-screen test

MIS system failure at results release time

Centre actions to mitigate the impact of the disruption

- *ICT system is backed up on a regular basis*
- *Seek ICT specialist help from external provider (TSI) to resolve the issue as quickly as possible*
- *Exams Officer will make entries from another site direct to the awarding bodies (using awarding bodies' secure extranet sites).*
- *Exam room scheduling/timetables compiled using alternative methods (alternative software/manual bookings and timetables).*
- *Exams Officer will contact awarding bodies in respect of re-sitting online exams affected by system failure, or to seek an alternative solution.*
- *In the case of a power outage, students using laptops for exams (due to Access Arrangements) will be able to continue their work using the laptops' internal battery.*
- *Laptops always fully charged at the start of exams and students to 'save' their work regularly.*
- *Results accessed directly from the awarding bodies' secure extranet sites (accessed from an alternative site if necessary).*

8. Emergency evacuation of the exam room (or centre lockdown)

Criteria for implementation of the plan

Whole centre evacuation (or lockdown) during exam time due to serious incident resulting in exam candidates being unable to start, proceed with or complete their exams

Centre actions to mitigate the impact of the disruption

- *Beech Lodge has a separate policy for emergency evacuation of the exam room (or lockdown) which details the responsibilities of staff and the actions to be taken in the event of an emergency.*
- *See evacuation sheet in each exam venue.*

9. Disruption of teaching time in the weeks before an exam – centre closed for an extended period

Criteria for implementation of the plan

Centre closed or candidates are unable to attend for an extended period during normal teaching or study supported time, interrupting the provision of normal teaching and learning

Centre actions to mitigate the impact of the disruption

- *The school would relocate to another identified area in collaboration with other local schools/organisations, within 5 to 10 days, in order that teaching and learning could be resumed, with priority being to students preparing for examinations.*
- *Head of Centre and centre staff to support students to access online lessons (via Teams).*
- *Apply for special consideration, if appropriate.*

10. Disruption caused by teaching staff/support staff industrial strike action

Criteria for implementation of the plan

Exams disrupted due to teaching staff/support staff participating in national industrial action

Centre actions to mitigate the impact of the disruption

- *Beech Lodge School is a private specialist school, and is not bound by the same pay negotiations affecting mainstream schools.*
- *If Beech Lodge were to be affected by industrial strike action, the Head of Centre would work with SLT to ensure that priority is given to ensuring that exam preparation, and exams, can go ahead as planned.*
- *In the case that exams are affected nationally, the Exams Officer will monitor communications from JQC and awarding bodies, and will act upon their instructions accordingly.*

11. Disruption to public transport preventing students from reaching examination centre

Criteria for implementation of the plan

Candidates unable to take examinations due to planned lack of public transport

Candidates unable to take examinations due to sudden disruption to public transport

Candidates arrive late due to public transport problems

Centre actions to mitigate the impact of the disruption

- *No students at Beech Lodge School currently travel by public transport (students are transported by parents/carers or taxis).*
- *Exams Officer or Head of Centre will liaise with students/parents/carers/taxi companies to ensure that they are all aware of any potential disruption to public transport that may have a knock-on effect to road travel (e.g. heavier than normal traffic).*
- *Students/parents/carers/taxis advised to allow for extra travelling time if necessary.*
- *Latecomers to be permitted to take their examinations providing they are within the JCQ regulations.*
- *Centres to apply to awarding organisations for special consideration for candidates where they have met the minimum requirements.*

12. Candidates may not be able to take examinations - centre remains open

Criteria for implementation of the plan

Candidates may not be able to attend the examination centre to take examinations as normal

Centre actions to mitigate the impact of the disruption

- *Request alternative centre for examinations, if required, due to not being able to get in to the school buildings.*
- *Medical needs student – if a student is unable to come into school, they are to have home invigilation, after requested and permission given from the appropriate examination boards.*
- *Special consideration to be requested, if appropriate.*

13. Disruption due to extreme weather

Criteria for implementation of the plan

Extreme weather causing disruption to exams

Centre actions to mitigate the impact of the disruption

- *In cases of high temperatures, Beech Lodge would take steps to ensure that students can comfortably sit their exams by:*
 - *Ensure doors and windows are open to allow ventilation;*
 - *Utilise exam rooms that are away from the glare of the sun;*
 - *Provide portable fans for exam room;*
 - *Provide chilled water for students.*
- *In cases of predicted inclement weather, the Head of Centre or Exams Officer would liaise with students, parents/carers and taxi companies to advise that they should allow for extra travelling time when heading to the centre.*
- *In the case that exams are affected nationally, the Exams Officer will monitor communications from JQC and awarding bodies, and will act upon their instructions accordingly.*

14. Centre may not be able to open as normal during the examination period

(Including in the event of the centre being unavailable for examinations owing to an unforeseen emergency)

Criteria for implementation of the plan

Centre may not be able to open as normal for scheduled examinations

Centre actions to mitigate the impact of the disruption

- *The school would relocate the Berkshire College of Agriculture, in order to take examinations, following a request to the relevant examination board to relocate the centre and having gained approval*
- *Notify the JCQ Centre Inspection Service of an alternative site arrangement by submitting the JCQ Alternative Site form online, using the Centre Admin Portal (CAP).)*
- *Special consideration to be sought, if appropriate*

15. Disruption in the distribution of examination papers

Criteria for implementation of the plan

Disruption to the distribution of examination papers to the centre in advance of examinations

Centre actions to mitigate the impact of the disruption

- *If security measures are compromised, the centre would inform the relevant examination board immediately to notify them of the issue.*
- *If the papers were not received within the timeframe, the Examination Officer would contact the relevant exam board.*
- *If the papers needed to be sent to a different venue as the centre is closed, a redirection notification would be sent to the board and to the couriers.*
- *Awarding organisations to provide centre with electronic access to examination papers via a secure external network. The Exams Officer would ensure that copies are received, made and stored under secure conditions. Awarding body guidance would be followed to uphold the conduct of examinations in such circumstances.*

16. Disruption to transporting completed examination scripts

Criteria for implementation of the plan

Delay in normal collection arrangements for completed examination scripts/assessment evidence

Centre actions to mitigate the impact of the disruption

- *The Examination Officer to securely place examination papers back into the secure storage area until the designated courier is contacted and picks up the papers.*
- *Examination Officer to contact relevant awarding organisations for advice as needed.*

17. Assessment evidence is not available to be marked

Criteria for implementation of the plan

Large scale damage to or destruction of completed examination scripts/assessment evidence before it can be marked

Completed examination scripts/assessment evidence does not reach awarding organisations

Centre actions to mitigate the impact of the disruption

- *Exams Officer to immediately communicate with relevant exam boards.*
- *Head of Centre to communicate with students and their parents/carers.*
- *Centre to apply for special consideration, if appropriate.*
- *All teacher assessed work to be backed up and copied before it is sent to the examination centre/examiner.*
- *All work to be backed up on the ICT system, if appropriate, which could be retrieved and then sent. This data will also be backed up regularly.*
- *Awarding organisations to generate candidate marks for affected assessments based on other appropriate evidence of candidate achievement as defined by the awarding organisations.*
- *Where marks cannot be generated by awarding organisations candidates may need to retake affected assessment in a subsequent assessment series.*

18. Centre unable to distribute results as normal or facilitate post results services

(Including in the event of the centre being unavailable on results day owing to an unforeseen emergency)

Criteria for implementation of the plan

Centre is unable to access or manage the distribution of results to candidates, or to facilitate post-results services

Centre actions to mitigate the impact of the disruption

Distribution of results:

- *Head of Centre/Exams Officer would make arrangements to access its results at an alternative site, the Berkshire College of Agriculture, in agreement with the relevant awarding organisation.*
- *Head of Centre/Exams Officer would make arrangements to coordinate access to post results services from an alternative site, Berkshire College of Agriculture.*
- *Request from the examination boards paper copies of results to distribute.*

Facilitation of post results services:

- *Contact our ICT external provider (TSI) to resolve ICT issues*
- *Head of Centre/Exams Officer would make arrangements to make post results requests at an alternative location, Berkshire College of Agriculture*
- *School to contact the relevant awarding organisation if electronic post results requests are not possible*

Contingency planning

Awarding organisations are required to establish, maintain and comply with an up-to-date detailed written contingency plan, to mitigate any incident they have identified may occur. This includes having communication plans for external parties (Ofqual General Condition of Recognition A6). Schools and colleges should also be prepared for possible disruption to exams and assessments and make sure staff are aware of these plans.

General contingency guidance

- emergency planning and response from the Department for Education in England
- handling strike action in schools from the Department for Education in England
- school organisation: local-authority-maintained schools from the Department for Education in England
- exceptional closure days from the Department of Education in Northern Ireland
- checklist - exceptional closure of schools from the Department of Education in Northern Ireland
- school terms and school closures from NI Direct
- opening schools in extremely bad weather - guidance for schools from the Welsh Government
- police guidance from National Counter Terrorism Security Office and partners on preparing for threats

Disruption to assessments or exams

In the absence of any instruction from the relevant awarding organisation, you should make sure that any exam or timetabled assessment takes place if it is possible to hold it. This may mean relocating to alternative premises. You should discuss alternative arrangements with your awarding organisation if:

- the exam or assessment cannot take place
- a student misses an exam or loses their assessment due to an emergency, or other event, outside of the student's control

You may also wish to see the JCQ's notice to centres on exam contingency plans and JCQ's notice on preparing for disruption to examinations in England, Wales and Northern Ireland for qualifications within its scope.

Steps you should take

Exam planning

Review contingency plans well in advance of each exam or assessment series. Consider how, if the contingency plan is invoked, you will comply with the awarding organisation's requirements.

In the event of disruption

- Contact the relevant awarding organisation and follow its instructions.
- Take advice, or follow instructions, from relevant local or national agencies in deciding whether your centre is able to open.
- Identify whether the exam or timetabled assessment can be sat at an alternative venue, in agreement with the relevant awarding organisation, ensuring the secure transportation of questions papers or assessment materials to the alternative venue.
- Where accommodation is limited, prioritise students whose progression will be severely delayed if they do not take their exam or timetabled assessment when planned.
- In the event of an evacuation during an examination please refer to JCQ's Centre emergency evacuation procedure.
- Communicate with parents, carers and students any changes to the exam or assessment timetable or to the venue.
- Communicate with any external assessors or relevant third parties regarding any changes to the exam or assessment timetable.

After the exam

- Consider whether any students' ability to take the assessment or demonstrate their level of attainment has been materially affected and, if so, apply for special consideration.
- Advise students, where appropriate, of the opportunities to take their exam or assessment at a later date.
- Ensure that scripts are stored under secure conditions.
- Return scripts to awarding organisations in line with their instructions. Never make alternative arrangements for the transportation of completed exam scripts, unless told to do so by the awarding organisation.

Steps the awarding organisation should take

Exam planning

- Establish and maintain, and at all times comply with, an up-to-date, written contingency plan.
- Ensure that the arrangements in place with centres and other third parties enable them to deliver and award qualifications in accordance with their conditions of recognition.

In the event of disruption

- Take all reasonable steps to mitigate any adverse effect, in relation to their qualifications, arising from any disruption.
- Provide effective guidance to any of their centres delivering qualifications.
- Ensure that where an assessment must be completed under specified conditions, students complete the assessment under those conditions (other than where any reasonable adjustments or special considerations require alternative conditions).
- Promptly notify the relevant regulators about any event which could have an adverse effect on students, standards or public confidence.
- Coordinate its communications with the relevant regulators where the disruption has an impact on multiple centres or a wide range of learners.

After the exam

Consider any requests for special consideration for affected students. For example, those who may have lost their internally assessed work or whose performance in assessments or exams could have been affected by the disruption.

If any students miss an exam or are disadvantaged by the disruption

If some of the students have been adversely affected by the disruption, you should ask the awarding organisation about applying for special consideration.

Decisions about special consideration, when it is or is not appropriate, is for each awarding organisation to make. Their decisions might be different for different qualifications and for different subjects.

Wider communications

The regulators, Ofqual in England, Qualifications Wales in Wales and CCEA Regulation in Northern Ireland, will share timely and accurate information, as required, with awarding organisations, government departments and other stakeholders.

The Department for Education in England, the Department of Education in Northern Ireland, and the Welsh Government will inform the relevant government ministers as soon as it becomes apparent that there will be significant local or national disruption; and ensure that they are kept updated until the matter is resolved.

Awarding organisations will alert the Universities and Colleges Admissions Service (UCAS) and the Central Applications Office (CAO) about any impact of the disruption on their deadlines and liaise regarding student progression to further and higher education.

Awarding organisations will alert relevant professional bodies or employer groups if the impact of disruption particularly affects them.

Widespread national disruption to the taking of examinations or assessments

The governments' view across England, Wales and Northern Ireland is education in 2022 to 2023 has returned to normal. Schools are open and examinations will go ahead in summer 2023.

As education is devolved, in the event of any widespread sustained national disruption to examinations or assessments, national government departments will communicate with regulators, awarding organisations and centres prior to a public announcement. Regulators will provide advice to government departments on implications for examinations and assessments, including exam timetables.

In November 2022, Ofqual and the Department for Education issued decisions following a consultation on the resilience of the qualifications sector for specific examinations awarded in England in summer 2023. Ofqual has published Guidance for schools, colleges and other exam centres on gathering evidence of student

performance for students entering GCSEs, AS and A levels, the Advanced Extension Award and Project qualifications to support resilience in the exam system in England in 2023.

The Department for Education has updated its guidance on handling strike action in schools in England in light of the industrial action in 2023. The guidance recommends schools should prioritise the running of examinations and assessments on any strike days, and should review their contingency plans to make this happen. Schools, colleges and other exam centres should speak to the relevant awarding organisations if they are expecting any disruption that might affect the sitting of exams and assessments.

We will update this page as necessary, with any further relevant links, should national disruption occur.

JCQ

15.1 The qualification regulators, awarding bodies and government departments responsible for education have prepared and agreed information for schools and colleges in the event of examinations being seriously disrupted. This jointly agreed information will ensure consistency of response in the event of major disruption to the examinations system affecting significant numbers of candidates.

15.2 In addition, awarding bodies have their own well-established contingency plans in place to respond to disruptions. It is important that exams officers who are facing disruption liaise directly with the relevant awarding body/bodies.

15.3 All centres must have a written examination contingency plan which covers all aspects of examination administration. This will allow members of the senior leadership team to act immediately in the event of an emergency or where the head of centre, examinations officer or SENCo is absent at a critical stage of the examination cycle. The examination contingency plan should reinforce procedures in the event of the centre being unavailable for examinations owing to an unforeseen emergency.

All relevant centre staff must be familiar with the examination contingency plan. Consideration should be given as to how these arrangements will be communicated to candidates, parents and staff should disruption to examinations occur.

15.4 In the event that the head of centre decides the centre cannot be opened for scheduled examinations, the relevant awarding body must be informed as soon as possible. Awarding bodies will be able to offer advice regarding the alternative arrangements for conducting examinations that may be available and the options for candidates who have not been able to take scheduled examinations.

15.5 The awarding bodies will designate 'contingency sessions' for examinations, summer 2024. This is consistent with the qualification regulators' document *Exam system contingency plan: England, Wales and Northern Ireland*: <https://www.gov.uk/government/publications/exam-system-contingency-plan-england-wales-and-northern-ireland>

The designation of 'contingency sessions' within the common examination timetable is in the event of national or significant local disruption to examinations. It is part of the awarding bodies' standard contingency planning for examinations.

In the event of national disruption to a day of examinations in summer 2024, the awarding bodies will liaise with the qualification regulators and government departments to agree the most appropriate option for managing the impact. As a last resort the affected examinations will be rescheduled. Although every effort would be taken to keep the impact to a minimum, it is possible that there could be more than one timetable date affected following the disruption, up to and including the last contingency day. Centres will be alerted if it is agreed to reschedule the examinations and the affected candidates will be expected to make themselves available in such circumstances. The decision regarding the rescheduling of examinations will always rest with the awarding body. The centre must conduct the examination on the scheduled date unless instructed to do otherwise by the awarding body.

Where candidates choose not to be available for the rescheduled examination(s) for reasons other than those traditionally covered by special consideration, they will not be eligible for enhanced grading arrangements. Centres must therefore ensure candidates and parents are aware of the contingency arrangements so that they may take them into account when making their plans for the summer.
